Insured amounts

- € 5.000,000,00 per claim for personal injury and/or material damage and/or financial loss.
- € 2.500,000,00 per event for Good employment practices.
- In a given policy year, VvAA shall reimburse no more than twice the insured amount.

End date of training and conversion into individual insurance policies

We advise you to contact VvAA approximately three months prior to the end date of your training to ensure that the above-mentioned insurance policies can be converted in good time into one or more individual insurance policies with adequate cover.

Membership of VvAA – exemption from membership fees

When you enter into an employment contract with SBOH at the start of your training, you will be eligible to become a member of Vereniging VvAA at no cost. This means you will be exempt from paying a membership fee. As a doctor in training at SBOH, you can indicate at the start of your contractual employment with SBOH that you wish to take advantage of the free membership of VvAA. In that case, SBOH will notify VvAA of that.

Upon termination of your employment contract with SBOH, you must contact Vereniging VvAA and your membership of Vereniging VvAA will be converted into a paid membership with the accompanying conditions, unless you indicate that you wish to terminate the membership.
